# **Important Safety Instructions**

#### 1.1 Important Notices

- Make sure to pay careful attention to the label of the lifting capacity attached on the lift and never try to lift cars above the lifting capacity labeled.
- Read this manual carefully before operating the machine so as to avoid personnel injury
- Users are not permitted to make any modification to the control or mechanical unit

#### 1.2 Qualified Personnel

• Only properly trained individuals are permitted to operate the lift.

#### 1.3 Warning Signs

 All safety warning labels are clearly depicted on the lift to ensure that the operator is aware of an avoids the dangers of using the lift in an incorrect manner. The labels must be kept clean and they have been replaced if detached or damaged. Please read the meaning of each label carefully and understand them for future operation

#### 1.4 Safety Instructions

- Make sure that you have read the User's Manual completely, including relevant instructions on installation, operation, and safety before operating the lift.
- This lift is designed for lifting vehicles 10,000 LBS and under. Any other use may result in damage of the lift or injury to personnel.
- Only those who have been properly trained should operate the lift. Customers or inexperienced persons should be prohibited from operating the lift at will.
- Do not load the lift beyond its rated capacity. To reduce the risk of injury, refer to loading instructions, and never attempt to lift more than the rated capacity.
- The lift is designed to lift the entire body of vehicles with weight within the lifting capacity.
- If the lift is designed for indoor use only, outdoor use is prohibited.
- Do not install the lift on any surface other than concrete that is at least 6" thick and has set for at least 30 days.
- Do not move away from controls while lift is in motion.
- Keep hands and feet away from any moving parts, do not put hands in any dangerous places, such as the space between tool arms.
- Do not wear any loose clothing that could be caught in moving parts. Keep hair, fingers, and all body parts away from moving parts. Always wear appropriate safety equipment during operation.
- Keep area around the lift clean to avoid incidents. Any oil stain or obstacle may pose a safety risk.
- Always ensure the safety latches are operational before any attempt to work near or under the vehicle.
- Always ensure the safety locks are engaged before any attempt to work near or under the vehicle.
- Never remove safety related components from the lift.
- Do not use if safety related components are damaged or missing
- Ensure all regular maintenance is completed. If anything abnormal occurs, stop using the lift and immediately contact us for help.
- Do not rock the vehicle while on the lift or remove heavy components that may cause weight shift, as the vehicle could fall.
- Do not modify any part of the lift without manufacturer's advice; THIS VOIDS THE WARRANTY and increases the chances of injury or property damage.
- If the lift is not in use, lower to the lowest position and disconnect power.
- It is prohibited to lift the vehicle while occupied.
- When a vehicle is being loaded or unloaded from the lift, no person is allowed to stand in the vehicle passage.
- Do not use the lift while tired, or under the influence of drugs, alcohol, or medications

- Keep areas well lit.
- Keep loads balanced on the lift platforms. Clear the area immediately if a vehicle is in danger of falling off the lift. DO NOT ATTEMPT TO CATCH A FALLING VEHICLE!
- Make sure there are no obstacles under the vehicle before lowering it
- If the lift will be left unused for a long period of time, it is recommended that the user disconnects power, empties the oil tank, and lubricates any moving parts with hydraulic oil



- Surrounding of lift will remain clear when raising or lowering

#### 1.6 Sound Level

The sound emitted from the lift should not exceed 75 DB.

#### 1.7 Special Reminder

- The newly installed lift can NOT directly lift vehicle, and should be raised to the highest point then lowered to the lowest point 2-3 times repeatedly without any load to bleed the air out from the hydraulic hose and cylinders to ensure the lift runs smoothly
- 1st time use of the lift with a load after bleeding air out of the the hydraulic hose and cylinders should follow the steps below
  - Loosen the screw cap of the hydraulic oil flow valve and tighten the middle hexagonal screw clockwise inward to the tightest position.
  - Press the "UP" button to raise the lift with loaded vehicle to your desired height.
  - Press and hold the "DOWN" button to wait for the safety lock to be disengaged, then adjust the hydraulic oil flow valve (the middle hexagonal screw) by turning the screw counterclockwise to make the lowering speed reach .5 in/sec or slower.

# Truck Adapters

All Stratus 2-Post lifts are compatible with the following truck adapters only. - Screw-Up Pad Extension - Height Extension Adapter



#### \*WARNING\*

The truck adapters cannot be stacked or used with other adapters. All Stratus adapters should only be used along with the appropriate components.

The Height Extension Adapter can only be used with the designated pad and CANNOT be stacked with any other adapter. See Fig. 3





The Height Extension Adapter should only be used with the appropriate exte- nion as shown above in Fig. 2



The Screw-Up Pad can only be used with the locking adapter as shown above on Fig. 1.







# **Installation Instructions**

#### 3.1 Precautions for Installation

- The joints of the oil hose must be firmly connected in order to avoid leakage
- All bolts should be firmly screwed up
- Do not place any vehicle on the lift during trial running

#### 3.2 Installation



- Remove the accessory packages, and take the parts out of their packaging.
- Be sure to check for any missing or damaged parts. Please call us immediately if there are any missing or damaged parts.
  - If you do not contact us and insist on installing with missing or damaged parts, we, nor our dealers will bear any responsibility and will charge for any parts subsequently damaged.





- Firstly, assemble the 2 posts.
  - Using the bolts provided, use them to connect the 2 pieces for each post.





• Once each post has been assembled, install the post cap for the cross beam.









1. Assemble overhead top beam.

NOTE: The bolts run from inside of the column and then fasten the nuts from outside of the column.




- 2. Install the overhead beam cable pulley Warning: Symmetrical installation and asymmetrical installation of the cable pulley positions are not universal. In-correct installation of the pulley positions may cause damage to the cable or the lift.
- For symmetrical installation, use the long shaft and the long shaft sleeve to fix the cable pulley (pre-installed) .
- For asymmetric installation, use 4 short shafts and 2 short shaft sleeves in the accessory box to fix the cable pulley

Note: During the installation, the positions of the cable pulley at both ends of the overhead beam should be installed correspondingly. There may be a gap between the cable pulley and the shaft sleeve, this is for the cable can be automatically aligned, normal abrasion. Do not add shim to fix the position of pulley, it may cause abnormal wear of the lift.



#### 2.3. Mounting position of cable pulley


Please Note: During the installation, the positions of the cable pulley at both ends of the overhead beam should be installed correspondingly. There may be a gap between the cable pulley and the shaft sleeve, this is for the cable can be automatically aligned, normal abrasion. Do not add shim to fix the position of pulley, it may cause abnormal wear of the lift.




#### 4.9 Position columns

Check if the columns are vertical to the ground with level, insert thin shims (come with package) to adjust when necessary

Symmetric installation




Asymmetric installation




Raise the carriage to the 1st locking position located at the bottom of the column .

Note: You can hear "click" once locked.




#### 4.11 Install cables (2 Cables in total)

#### 4.12 Routing the safety release cable

- 1. The safety lock has been pre-installed.
- 2. Install safety lock release cable to connect the safety lock on the main column and vice column. (Fig 22)
- 3. Install safety lock cover.

NOTE: Press the single point lock release lever on the main column to check if this lever can release the mechanisms in both columns at the same time. Adjust the safety lock release cable adjustment screw if necessary, until the lever can release the mechanisms in both columns at the same time.





• Once the cross beam has been assembled, and the post have been stood up, install the cross beam onto the posts with the bolts provided.





- NOTE:
  - The cross beam must be installed with the 3 holes on the cross beam placed on the side of the main post, and the 2 holes on the cross beam placed on the side of the secondary post.
- With the cross beam installed, install the cross safety bar







• Next, route the cables and hydraulic hoses.







• Next, install the mounting bracket for the pump, and proceed to install the pump



• Connect the hydraulic hose from the post to the pump





• With the pump installed, connect the wiring and safety lock release lever

#### Installation of power unit

1. 2. Attach the power unit onto the bracket on the power side column;


Secure it using nuts M10X20, the locking washers D.10 and washers D.



#### 4.14 Connection of hydraulic hoses

Connect the longer hose in between the 2 cylinders, connect the short hose in between the cylinder and the power unit. Please hand tighten to avoid thread damage, then use hand wrench to fasten completely.





#### 4.15 Make the electrical connection

Make sure all wiring are same as below circuit diagram.

Attention: electrical system connection must be done by licensed electrician.

- With the pump installed on the main post, assemble the arms
  - Line up the holes on the arms with the holes on the lifting carriage, and insert the pin
  - Install the 3 stage arm in the back, and the 2 stage arm in the front of the lift.

# **Operation Instructions**

#### 4.1 Precautions

- · Check all the joints of the oil hose to ensure there is no leakage
- If the safety device of the lift malfunctions, the lift shall not be used.
- The Machine shall not lift or lower an automobile if its center of gravity is not positioned midway between the rising platforms.
  - If the lift is used while the vehicle's center of gravity is not positioned midway between the rising platforms, Stratus, as well as our dealers will not bear any responsibility for any consequence resulted thereby.
- All individuals should stand in a safe area away from the lift during the lifting and lowering process.
- Make sure the safety lock is engaged before you begin working under the vehicle.
- No people are permitted to be under the vehicle during the lifting and lowering process.

#### **4.2 Operating Instructions**

#### Raising the lift

- Make sure that you have read and understood the operation manual before operation.
- Drive and center the vehicle in between the posts.
- Adjust the lift arms so the vehicle is positioned with the center of gravity between the pads
- Ensure all arms are contacting the vehicle at the designated lift points
  - MAKE SURE THE ARM SAFETY MEASURES ARE ENGAGED
- Raise the lift by pressing the lifting button adaptors contact the underside of the vehicle
  - MAKE SURE THE VEHICLE IS SECURED
- Proceed pushing the lifting button until the desired height has been reached

#### Standing

- Once the lift is at the desired height, press the lowering lever to engage the nearest locking position
- Always ensure that the lock in each column is engaged before any attempt is made to work on or near the vehicle.

#### Lowering the lift

- Raise the lift to release pressure on the locking mechanism
- Release the locks manually with the safety lock lever
- Lower the lift by pressing the lowering lever
- Before removing the vehicle from the lift area, position the lift arms and pads out of the vehicle's way to provide a clear exit way
  - NEVER DRIVE OVER THE LIFT ARMS

# **Frequently Asked Questions**

- What thickness of concrete do you recommend?
  - We recommend 6-12 inches of reinforced concrete that has cured for at least 30 days.
- What is the recommended PSI for the concrete?
  - We recommend a psi of 3,000
- What kind of oil do I use?
  - AW32 or AW46 hydraulic oil
- Does this lift come with a plug?
  - The lift does not come with a plug, you will need to get a 110V, or 220V connection with plug
- How do I hook up the electrical?
  - o Yellow Green Wire: ground Wire
  - o Blue and Brown Wire:
    - If using a 110V power supply either the blue or brown wire can be wired to be hot. If the blue wire is selected to be hot, the brown wire will be neutral and conversely if the brown wire is selected to be hot, the blue wire will be neutral
    - If a 220V power supply is used, both the blue and brown wires will be hot

### **Maintenance**

- Daily Pre-operation
  - Check hydraulic connections and hoses for leaks
  - o Check mechanical locks audibly and visually while in operation
  - Check arm locks
  - Check bolts, nuts, and screws are tight
- Every 1 Month
  - Check all cable connections, pins and bolts to insure proper mounting
  - Inspect all anchor bolts and retighten if necessary
  - Check columns for square-ness and plumb
  - o Check equalizer cable tension, adjust if necessary
  - Check safety cable, adjust if necessary
  - o Check all arm pivot pins. Make sure they are properly secured
  - o Check all lifting pads, replace if necessary
  - o Lubricate columns with grease
  - o Check the hydraulic oil, fill or replace if necessary
  - o Check hydraulic systems for proper operation
- Ever 12 Months
  - o Verify that all components and mechanisms are not damaged
  - Verify the equalizer cables are not worn, change if necessary
  - Check the electrical system to verify that the motors operate properly (This work must be carried out by skilled electricians)
  - Empty the oil tank and change the hydraulic oil

### Warranty

- 5 years lifting structure Post, Cross Bar, Carriage, Arms, Safety Locks, Safety Lock Pins, Arm Pin, Runway
- 3 years hydraulic Power Unit/Station, Cylinder
- 2 years electrical Electrical, Buttons, Solenoid, Limit Switch
- 1 Year Balance Cable, Safety Lock Release Cable, Safety Covers, Support Bar, Ramps, Hydraulic Hose, Fittings
- No Warranty Door Guard, Rubber Pads, Truck Adaptors

#### Environmental damage:

• Only appropriately trained personnel may dismantle and dispose of the unit.

#### Dismantling:

• To dismantle the product, proceed as follows:

#### FLECTRICAL HAZARD!

• When carrying out any decommissioning and dismantling work on the unit, switch off all power supply connections, ensure they cannot be switched on unintentionally and verify that they have been disconnected. Earth and short-circuit them, and cover or otherwise isolate any neighboring live parts. Failure to do so may lead to serious injuries or death.

#### HIGH PRESSURE HAZARD.

- When carrying out any unit decommissioning and dismantling work, close off and empty all the connection pipes until the pressure is the same as the ambient air pressure. Failure to do so may lead to injury.
- Make sure that the hydraulic circuit has been switched off. Close all hydraulic shut-off valves.
- Disconnect all connections, making sure at the same time, that no operating materials escape, such as oil, refrigerant and water-glycol mixture.
